**Evaluation Methods Used:** The testing of the College Tuition Insurance application and preparation of this document was performed by Tenon, LLC and involved extensive use of leading assistive technology including NVDA, JAWS and VoiceOver screen readers, Dragon Professional speech

recognition software, Windows High Contrast themes, screen magnifiers, as well as exclusive use of the keyboard. Native platform accessibility features were also used to assist with testing.

## Audit Summary

During the period of July 1, 2021 and July 27, 2021 Tenon LLC performed an audit of the GradGuard College Tuition Insurance web application. Tenon's auditing staff assessed distinct user interface components representing key features and functionality of the product. Tenon staff assessed the components against over 200 accessibility checkpoints aimed at determining compliance against the Web Content Accessibility Guidelines (WCAG) version 2.1 at Level AA compliance. This process revealed 17 accessibility issues. GradGuard was able to address and remediate all the issues which were then were retested by Tenon to confirm that each issue was resolved.
